Subject: Expanding the uniform list of services to be followed in Special Economic Zones.

The approval of the Ministry of Commerce & Industry, New Delhi regarding ... Uniform list of services containing 58 Nos. of Service items communicated vide letter No.D.12/25/2012-SEZ dated 16-09-2013 has been circulated vide this office Circular No. 2/2013 dated 26-09-2013 to all Developers, Co-Developers and Units in SEZs coming under the jurisdiction of this office to enable them to avail the service tax benefits by default. Further, Ministry of Commerce & Industry vide letter No. D.12/19/2013-SEZ dated 19-11-2013 has communicated approval of two more service items (Rent-a-Cab Scheme Operators Services and SEZ Online Services) to include in the uniform list of services. Accordingly, the same has been placed in the Unit Approval Committee meeting of respective SEZs and approved. The Department of Commerce vide their letter No. D.12/19/2013-SEZ dated 19-06-2014 has again expanded the uniform list of services from the 60 Nos. of services to 63 Nos. (Air Travel Agent Services, Rail Travel Agent's Services and Travel Agent's Services) and which has been included in the default list of service and circulated vide this office Circular No.1/2014 dated 02-07-2014 to all SEZs entities of Kerala and Karnataka.

The Department of Commerce vide letter F. No. D. 12/19/2013-SEZ dated 09-07-2014 has now expanded the uniform list of service from the existing 63 nos. of services to 66 nos. for carrying out authorized operations of entities in SEZs under the jurisdiction of Zonal Development Commissioner, Cochin SEZ. The following are the services now included in the default list of services:-

- 1. Business Support Service.
- 2. Transport Passengers by Air.
- 3. Accommodation Service.

The approval of the additional three more services are circulating to the SEZ entities to enable them to avail the service tax benefits for their authorized operation. The consolidated list of services containing 66 nos. is attached as Annexure-A. The Service Tax exemption of these services is subject to the provisions of Department of Revenue Notification No. 12/2013-Service Tax dated 01-07-2013.

In case the Developer/Co-Developer/Unit require any particular services, which have not been included in the default list, for carrying out their authorised operations, they may approach the respective Approval Committee with adequate justifications on its nexus with their authorised operations.
